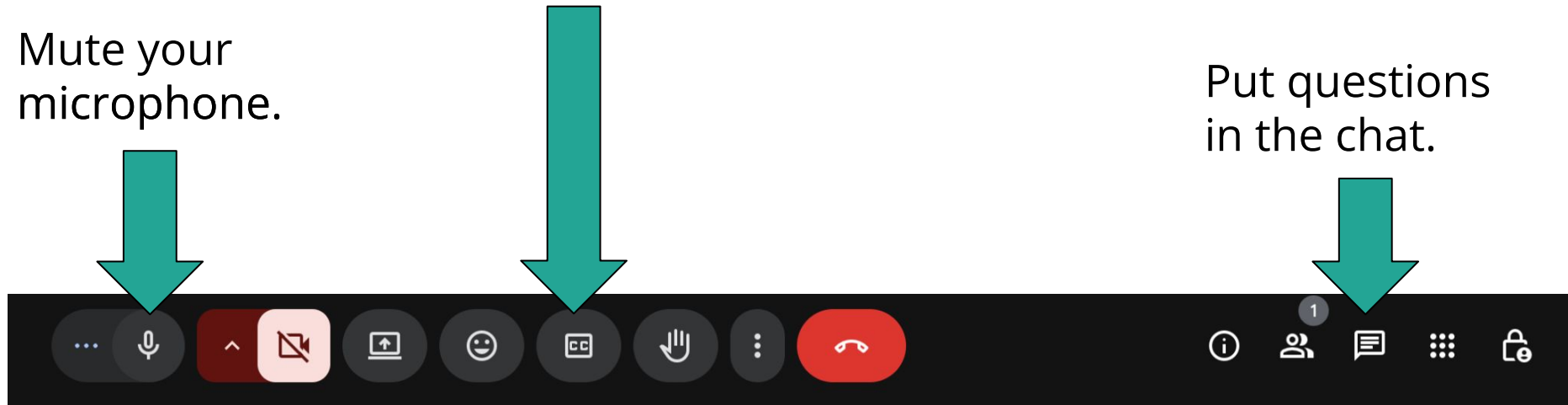

 - Many DSPD items were removed from the SSA committee's list of recommended potential cuts.
 - The SSA committee will vote on cuts and funding requests Monday.
 - After that, the Executive Appropriations Committee will vote on Feb. 9 on that and other subcommittee funding recommendations.
